Deferred to the professionals for discussion of the following items: Updates on obtaining financing for the Capital Improvement Projects; Various Billing Disputes/Issues; Brown water complaint received and addressed by the Engineer.

### ENGINEER

Justin Mahon submitted report, which is on file and discussed the following items:

He hopes to complete the bid specifications for the valve exercising project by the end of May.

Assistance was provided to the MUA to resolve brown water complaint from 63 Squawbrook. Status report was provided to the North Haledon Mayor.

Assisted Operators in the elimination of a broken valve at the intersection of Belmont Avenue and High Mountain Road that was leaking water into Molly Ann Brook.

Initiated work to render the renovation of the Heights Tank "bid ready" based upon authorization at the prior meeting. The project is ranked number 188 on the NJEIFP priority list which may be high enough to receive financing in 2019.

Work to render the replacement of the High Service Pump Station "bid ready" remains on hold. The project is ranked number 457 on the NJEIFP priority list which is unlikely to be high enough to receive financing in 2019.

No new information was provided regarding the status of NJEIFP funding. Discussion was held on alternative financing options.

The Emergency/Repair Contractor was mobilized to repair a water main break on Sherwood Avenue on May 7. 18 services were impacted by the controlled shutdown. All follow-up samples were absent for Total Coliform.

Final re-submittal of the Lead & Copper and WQP Sampling Plans is anticipated on May 22.

The air permit for the generator servicing the Filter Plant has been completed and uploaded to the NJDEP.
