• REPORTS AND DISCUSSION

CHAIRMAN

Victor D'Ambrosio discussed the following:

Last meeting the Auditor distributed various versions of the 2020 Budget and potential rate increases for review and consideration. Further discussion will be held under the Auditor's report. Notices were sent to customers regarding the Valve Maintenance Program.

Estimates were received regarding repair work needed on the Weil McLain hot water boiler located at the MUA facility on High Mountain Road. The cost to install a new water feed control valve and backflow vale is \$525.00. In addition, two options were presented concerning the replacement of the 10 year old expansion tank: (1) new larger tank for \$650 or (2) new same size tank for \$250. The larger tank will help with the tank pressure which is currently 5 pounds and should be 12 pounds.

The letter has been drafted concerning 570 Preakness; however, it is still under review. Discussion held regarding the Roe Street letter.

Received a request concerning 198 Squaw Brook Road. Further discussion will be held under the Engineer's report.

Discussion held regarding a North Haledon traffic control invoice with an extremely high administrative cost. Follow-up will be made concerning the administrative fee.

ENGINEER

Justin Mahon submitted report, which is on file and discussed the following items:

Engineer is monitoring contract with Garcia Construction for locating valves and hydrants and exercising valves to satisfy the WQAA requirements. 78 were done as of November 14, 2019 and work is required on 20.

Discussion held concerning the request from 198 Squaw Brook Road to discontinue service. The MUA recommended that the customer obtain service from the Borough of Hawthorne several years ago based upon its location. The MUA will treat the service as a tear down and/or vacant lot and will discontinue its service accordingly.

Discussion held regarding 33 Sicomac water service application for a multi-use commercial property. The Engineer will discuss easement options with the property owner prior to formal approval of the application.

The updated non-revenue water numbers are still high and investigation continues as to the reasons for this situation.

ATTORNEY

Casey Cordes submitted report, which is on file and discussed the following items:

Two OPRA requests were received this month, which were processed and responded to timely in accordance with state law.

The Developers Agreement for the 920 Belmont projects has been finalized between the professionals and is submitted for consideration.

The Operations Committee continues to work to enhance operational and staffing matters. Discussion was held concerning some specific staffing issues.

AUDITOR

Robert McNinch discussed the following:

Discussion held regarding 2020 Budget and Rate Increase projections. After lengthy discussion, the Board directed the Auditor to prepare the 2020 Budget with a projected three percent (3%) rate increase.

LICENSED OPERATOR

Greg Cardena discussed the following items:

The header at the Central Avenue Pump Station is leaking. Following review by Arcadis, the Licensed Operator is preparing a spot repair. A quote has been solicited for replacement and Arcadis will review the options for repair and replacement.

On November 15, 2019 a low clear well alarm was received. The Licensed Operator's staff responded to the alarm condition and contacted PVWC to check on the status of the Burhans Pump Station. It appears the Burhans Pump Station was not pumping. PVWC turned the pumps on and the alarm condition restored. On November 17th another alarm condition occurred, contact was made to PVWC again and the alarm condition restored. The MUA Licensed Operator has contacted the PVWC Licensed Operator for PVWC to confirm the operational status of the Burhans Avenue Pump Station.
