A Stop Work Order was issued by the Engineer for the 920 Belmont project, which will be discussed further under the Engineer Report.

Tree removal quotes have been received in accordance with state law requirements and will be considered for approval.

Arcadis has submitted a proposal for the Heights Tank project.

Arcadis submitted an Asset Management Plan, which is under review.

Edmunds has submitted its annual service contract for consideration. There are no increases in fees.

The meter software upgrades are proceeding.

The letters for 550 and 558 Belmont have been sent; however, one was returned. The Clerk got the new mailing address for 558 Belmont and the letter will be re-sent.

One quote was received for the purchase of a new vacuum in the amount of \$17,000.00. He will ask Anthony Harrington to get additional quotes.

New Water Billing Clerk has started and is motivated to learn, which is good news.

ENGINEER

Justin Mahon submitted report, which is on file and discussed the following items:

Discussion held regarding the Heights Tank project proposal. The costs under the Design part of the projects have increased by approximately \$9,000.00.

Discussion held regarding the Stop Work Order issued for 920 Belmont due to work proceeding without notification to the Authority's Engineer so that inspections of installation could take place. Eric Keller of Bowman providing documentation of proper line installation, including pictures and field reports along with a Certification of proper completion. The Engineer is waiting for these outstanding items.

Discussion held regarding the need to amend the Resolution for 555 Preakness since the Applicant is changing the location.

Repairs were completed at 15 Park Street, North Haledon.

ATTORNEY

Casey Cordes submitted report, which is on file and discussed the following items:

The Interlocal Service Agreement between the Authority and the Borough of Haledon was updated and sent to the Borough for review, comment and/or execution. Discussion held concerning the procurement of a mobile phone for stand-by emergency operator's use.

The Developers Agreement for the 920 Belmont project was amended to include indemnification of the Authority for the Developer moving forward with certain work prior to receiving the final NJDEP Permit approval.

AUDITOR

Robert McNinch discussed the following:

2020 Budget was able to absorb the non-revenue water losses due to the large amount of connection fees received (approximately \$324,000.00) on various development projects.

The projections for the 2021 Budget shows that the standard 2% rate increase will only be able to absorb 5-6 months of the losses. Discussion was held concerning costs and potential scenarios for 2021 rate increase numbers.

Next meeting, he will bring comparisons of numbers along with the standard increases instituted by other utility authorities.
