REPORTS AND DISCUSSION

CHAIRMAN

Victor D'Ambrosio spoke on the following:

He received an email concerning the utility lien sale. There are only a couple of delinquent accounts. The total owed to the MUA is approximately \$40,000.00.

The MUA needs to purchase meters. A quote was received for \$9,200.00.

The professionals have completed the Lead & Copper response to the NJ DEP. New sampling locations have been identified.

The MUA is aware that the Borough's DPW Superintendent is retiring in March and the filter plant employee is reducing his hours. The Borough will handle how the schedule is covered. Low pressures were reported at 417 Heights Drive, which will be reviewed.

ENGINEER

Justin Mahon submitted report, which is on file and addressed any questions.

He investigated the low pressure reported at 417 Heights Drive. The likely cause of the low pressure is the fact that Passaic Valley Water had a tank down and was drawing on this tank so it takes longer to fill.

He is coordinating with the Licensed Operator to response to the NJ DEP concerning the water conversation and leak detection plan. The Engineer updated the water audit and completed the spreadsheet for submitted to the NJ DEP. The MUA's unaccounted for water percentage for December 2015 through November 2016 was 12 percent which did not trip the requirement to submit a list of planned actions to the NJ DEP.

He assisted the Licensed Operator in addressing the leak at the Central Avenue Pumping Station. Obtained a price of approximately \$10,000.00 to replace a suction header; however, the issue of who would install the header is unresolved. This will be a 2017 capital improvement. He recommended either obtaining three quotes or using the Licensed Operator under the professional service agreement.

He provided an update concerning the 2014 Water System Improvements Project. The meter pit at Acquackononk Village is being dropped from the project because the Authority is unable to resolve its location with the property owner.

ATTORNEY

Adam Boyle submitted report, which is on file and addressed any questions.

AUDITOR

Chuck Ferraioli spoke on the following:

He recommended holing the public hearing for the 2017 Budget tonight; however, the MUA cannot pass the 2017 Budget until next month since it is still under review by the Local Finance Board.

LICENSED OPERATOR

Robert De Block submitted report, which is on file.

He has a meeting tomorrow concerning replacing the mercury switch on the Central Avenue Tank.

He explained and discussed the response to the NJ DEP letter regarding Lead and Copper Rule Requirements. Based upon their actions, they will be able to update the MUA's sample pool to ensure compliance. He anticipates that the MUA will return to standard monitoring (60 locations / 6 months).
