Chuck Ferraioli, the MUA Auditor

He provided testimony to support the 2011 Connection Fee of \$2,045 based upon the statutory calculation as well as the 2011 Budget of \$2,335,000. Mr. Ferraioli explained the need for the four percent (4%) rate increase was based primarily upon the Passaic Valley Water Commissions rate increase of five percent (5%) from whom the MUA purchases its water as well as the increase costs of repairs and PSE&G bills from last year.

John Block-337 Morrissee Avenue, Haledon

Mr. Block understands with PVWC raising rates there is need of a rate increase. He states, residents are able to conserve water in order to keep their water bills lower but with the flat service charge being a fixed amount, residents are not able to conserve on this charge and recommended that the increase of rate not apply to the service charge.
