• REPORTS AND DISCUSSION

CHAIRMAN

Victor D'Ambrosio spoke on the following:

He gives a special thank you for everyone attending the meeting since it was scheduled on President's Day.

He would like to thank the Mayor for re-appointing him as well as his fellow commissioners for electing him as Chairman for the 2011 term.

The MUA closed on the temporary note \$1,000,000.00. The MUA was able to pay down the original 2010 temporary note of \$1,500,000.00, which he was obviously happy about; however, he is going to research financing alternatives for next year. He thanked the professionals for getting the closing accomplished.

He sent a letter to the Haledon and North Haledon Planning Boards to ensure that the MUA application is included in their reviews in order to expedite the application process for members of the public.

Billing fell behind due to software issues. He is working with the water clerk to issue credits that are due. Cycle 2 will be issued a 2.21% credit on next bill and cycle 3 a 2.74% credit.

He apologizes to Haledon & North Haledon for the incorrect billing on fired hydrants.

There was a recent article in the newspaper and a report by the Governor's office on local government entities and transparency. The MUA was listed under the Borough of Haledon. The MUA received a 3.5 rate out of 6 marks for transparency. The MUA will look at the constructive criticism and make changes. In the future the MUA will modify its website to post the Agenda, Minutes, Financial Statements, Audit, etc.

This year he plans to hopefully organize and implement a Leak Detection Plan along with Valve Cleaning and Maintenance. He also hopes to formulate a plan for the Filter Plant, revise the MUA's Rules and Regulations along with completing the first MUA Policy Manual.
