### **CHAIRMAN**

Victor D'Ambrosio spoke on the following:

He advised that the utility lien sales for delinquent water accounts in both Haledon & North Haledon are in progress. He thanked both Boroughs for providing these services and confirmed that both Boroughs will be compensated for all costs associated with the sales by the Authority.

Mr. Scrivens attended the January MUA meeting stating he had very low water pressure. He was away in February and is here at the March meeting to follow-up. A leak was found and repairs were made. He states the contractor left dirt behind and a week later the lines were flushed. Mr. Scrivens suggests the MUA notify residents if and when lines are to be flushed because his water heater gets clogged when this is done.

The leak was fixed and as to the low pressure issue, the MUA is working on updating its Capital Improvement Plan, which will factor in addressing this issue in his area. The Licensed Operator apologized for failing to notify him about the line flushing. Mr. Scrivens was also advised to contact Denise Wahad once the snow clears so that his property can be cleaned up.
