• REPORTS AND DISCUSSION

CHAIRMAN

Victor D'Ambrosio spoke on the following:

He was approached by Franklin Lakes to potentially put a cell tower near the filter plant and talks are ongoing.

We received three price quotes for a new computer for the filter plant office. He suggests purchasing the mid-grade computer at a cost of \$710.00.

The Mayor of Haledon suggested that the MUA consider implementing an on-line payment system. Generally, there is a 1-2% fee associated with this service that is paid by the users. He will research this option and return to the Board with more information. As per the Auditor, this system would likely help with cash flow. If it is a more convenient service, the MUA should consider doing it.

He thanked Commissioner Van Sickle for his efforts to obtain State-bid price quotes for the trucks that a needed by the MUA. The two trucks that they had were a 1992 and 1997, one was in an accident and the other is inoperable). The total cost of the two trucks will be approximately \$66,000.00.

He received a request for a connection fee adjustment, which will be addressed with the user, Engineer, and Auditor.

ENGINEER

Justin Mahon submitted report and is on file.

He advised that the 2014 Projects should be done as soon as possible but interim financing would need to be obtained.

He stated that the 2011 Project will also need interim financing for the Contractor's April payment as well as the outstanding balance owed to Malcolm Pirnie for engineering costs.

AUDITOR

Chuck Ferraioli explained that in order to obtain interim financing for the 2014 Projects, the list of projects must be sent to the State in May of 2013 and the contracts for the projects must be awarded.

As for the 2011 Project, the final loan documents will be sent on April 19 and the Bond closing shall take place on May 27. Based upon these dates, interim financing is needed and a Resolution has been presented to add to the Agenda tonight to accomplish this financing.

As of February, the receivables are down by approximately \$16,000.00 from this time last year; however, there is still a substantial amount of receivables that need to be reviewed and retrieved.
