The Engineer tabulated the four (4) bids received and determined that the lowest bid for the 2014 project was approximately \$1,100,000.00. The company is Haskell Paving, Inc. The MUA needs the authorization from the NJ DEP to award the contract.

The MUA has adopted a new sampling plan; however, the old sites will continue to be sampled until the new sites can be installed.
