### **CHAIRMAN**

Spoke on the following.

Thanks Mr. Van Sickle for running the April 11, 2011 MUA meeting in his absence. Sends condolences to Thomas Maselli's family. Tom served on the Haledon Planning Board. USDA grant money in the amount of \$450,000 is still pending, but will hopefully be received over the next several months.

MUA to release Management Representation Letter in order for the Auditor to complete the 2010 Audit.

The current banks will start charging service fees, the MUA will look into new providers since it is uncommon for banks to charge such fees to municipal entities.

MUA Assistant Secretary attended and gathered material form the Renewal Energy Program. Leak detection work has not started but the first meeting shall be held soon. This work will be done at night and all personnel will be required to wear appropriate identification throughout the project.

NJEIT Funding second offer this fall-75% interest free/25% low interest. There is no debt forgiveness potion but it is still a very favorable financing option.

Need to be mindful of the fact that MUA debt service will increase next year and need to plan accordingly.

MUA is working on its website to include more information on fees, Minutes, & Agendas. MUA is looking into offering discount to Senior Citizens who qualify for certain real estate discounts (similar to Hawthorne Water Department's program).

2011 Connection fee policy needs to be examined.
