CHAIRMAN

Victor D'Ambrosio spoke on the following:

He explained the need for the Special Meeting last month to address Change Orders for ongoing construction project and to pay certain bills that could not wait since a quorum was not available for the regularly scheduled meeting in April.

He extended his and the MUA's sincere condolences to the Borough of North Haledon Mayor George on his wife's passing.

He thanked the Licensed Operator and DPW Staff for their efforts in getting the Central Avenue Tank operational.

He advised that the permanent financing closing with the NJEIT will take place on May 20, 2014 for the three capital improvement projects that are close to completion.

He stated that the MUA staff is still working on making the online payments available for customers.

He reported that the water lien sales are in progress with the Tax Collectors in North Haledon and in Haledon. The North Haledon sale will take place in June and the Haledon sale will take place in September.

He advised that the hydrant flushing will begin on May 5, 2014.

He stated that the CCR should be going out next month.

His office was contacted by representatives from Franklin Lakes regarding improvements to the roadway, which is located outside of the MUA's easement border. Discussion was held concerning the request from Franklin Lakes for the MUA to make roadway improvements.
