• REPORTS AND DISCUSSION

CHAIRMAN

Victor D'Ambrosio spoke on the following:

The MUA's F150 truck was involved in another accident. A Borough of Haledon garbage truck hit the vehicle while it was parked. The repair cost is \$2,400.00 and the MUA's insurance deductible is \$2,500.00. The MUA will make a request that the Borough pay for the repair costs. The MUA received a request from Franklin Lakes to install a guardrail on a roadway near the former filter plant location. The issue will be discussed in closed session since it involves negotiation of a potential contract for this service.

Commissioner Zofrea has advised the MUA that some North Haledon delinquent customers do not have curb boxes, which are needed to discontinue service for these accounts. The Licensed Operator advised that some may be buried from paving over the years; however, all ratepayers should have one. The addresses will be obtained from Joanne on the delinquent accounts and the curb boxes checked on an individual basis.

The schools in North Haledon owe the MUA a substantial amount of money. It is the intention of the MUA to send a Notice of discontinuation of service in the summer since school will not be in session.

Construction is winding down on the ongoing projects.

ENGINEER

Justin Mahon submitted report, which is on file and highlighted the following:

The Engineer will be advertising the bids for the 2014-2015 Water Distribution System Maintenance Construction and Emergency Repairs Contract.

The Former Filter Plant/High Service Reservoir is in progress and close to completion.

The Central Avenue Tank Project is in progress and close to completion.

The Engineer is working on the updated Capital Improvement Plan. Some draft documents were provided to the Commissioners for review and discussion was held concerning the documents provided.

Chuck Ferraioli spoke on the following:
