#### REPORTS AND DISCUSSION

#### **CHAIRMAN**

Victor D'Ambrosio spoke on the following:

The Contractor discovered an emergent leak at a 16 inch valve on High Mountain Road. The leak was addressed and the valve replaced instead of repaired due to its condition. Hundreds of notices were sent to affected ratepayers and boil water notices were issued as a precautionary 06/10/13

measure. All tests were negative and the water was deemed safe for use; however users were advised to run facets and hydrants were flushed in order to remove the cloudiness that results from these conditions. He thanked the MUA staff for their efforts during this emergent situation. The MUA received its Consumer Confidence Report and all items were in compliance. There were two corrections that were made listing the MUA's correct meeting dates and business address.

He advised the there were several projects ongoing with the following updates:

- (1) 2011 Water Main Improvement Project-the work is proceeding quickly and is almost complete. Due to problems in obtaining Easements in certain areas, a portion of the work will be deleted from the project. The pipe that was intended to be used in that area has already been purchased; therefore, the MUA intends to keep that pipe and use it for future projects. Funds are available through the NJEIT financing since the closing took place last month.
- (2) Central Avenue Standpipe Rehabilitation Project-the award of this Contract is before the MUA for approval tonight.
- (3) Filter Plant & High Service Reservoir Project-No bids were received after the second advertisement for same. The MUA is now seeking proposals from two contractors in order the negotiate a contract for the completion of this work; however, only one proposal has been submitted to date.

The MUA is researching providing users with the option of making credit card and on line payments. There is a two percent (2%) fee that will be associated with this service that would have to be paid by users who take advantage of this service.

The MUA plans to update its Capital Improvement Plan since it has not been done since 2000 and some projects have obviously been completed since that time.

The MUA has been notified that Home Serve letters have been sent to users. The MUA is not associated with Home Serve; therefore the MUA does not recommend or discourage individuals from considering the use of this service.

The NJ DEP has done an inspection of its facilities. Most of the issues raised are located at the MUA's filter plant property, which will hopefully be address in the next anticipated project. The Licensed Operator is working on a response to all raised concerns.

The MUA had agreed to re-examine the water use at one of its businesses to confirm the connection fee amount charged to the business last year. Based upon the review of the MUA's engineer and auditor, the MUA owes the business owner back funds because the original EDU calculation was too high. This will be addressed at next month's meeting.

### MUA COMMISSIONERS RESPONSES TO PUBLIC COMMENT/INQUIRIES

The Chairman advised Mrs. Halverson that the Contractor notified the MUA about the leak on High Mountain Road and the MUA immediately took action. Construction notices were only issued to affected areas and it was not anticipated by the MUA's engineer, Licensed Operator and Contractor that her area would be affected so a Construction Notice was not sent to her address. The MUA's Licensed Operator will send someone to her address to check her service. The relining of the High Mountain Road water main is on the MUA's Capital Improvement Plan; however, it was not a high priority item. The MUA cannot anticipate a timeframe for this project since there so many factors to consider. The MUA has spent \$15,000,000.00 on improvements to its system since the Capital Improvement Plan was put in place and it hopes that it will be able to do more.
