REPORTS AND DISCUSSION

CHAIRMAN

Victor D'Ambrosio spoke on the following:

Discussion was held concerning a letter received from Heights Drive requesting that the MUA repair its roadways. The MUA is not responsible for these public and/or private roadways and the Chairman will send a letter confirming same to the Association.

Discussion was held regarding the purchase of a new laptop computer for administrative use.

He thanked Commissioner Flach for her efforts in the hiring of the MUA's first summer intern.

Meters must be purchased for the 960 Belmont project. The cost of the meters is \$6,760.00.

The MUA has received proposals for maintenance and upgrades for the MUA's website. Two quotes were received that must be reviewed.

He deferred all other issues for discussion under the professional reports.

ENGINEER

Justin Mahon submitted report, which is on file and addressed any questions.

He discussed the part needed for the Central Avenue tank repair.

He reviewed and explained Change Order #2 for the 2014 Water Improvement Project. Discussion was held concerning the Change Order.

He confirmed that no water mains have been installed to date at the 960 Belmont project despite the article in the Bergen Record stating that the property would start showings for potential purchase/rent in July 2017.

There was no new information on the Passaic County requirement for a Traffic Control Plan. The Squaw Brook project was completed. He believes that the county will require the MUA to address Traffic Control Plans on a case by case basis.

He discussed the Meter Replacement Pilot Program.

ATTORNEY

Casey Cordes submitted report, which is on file and addressed any questions.

She confirmed that the Stipulation of Dismissal was filed in the matter of the North Haledon Board of Education v. MUA on May 11, 2017 since the settlement funds were received by the MUA on May 1, 2017. Therefore, the lawsuit is formally concluded.

She provided updates on various contracts involving the MUA.

She provided information to the Auditor concerning the 2016 Audit.

AUDITOR

Chuck Ferraioli spoke on the following:

He distributed the 2016 Audit, which had no professional recommendations for improvement.

The MUA's cash receivables were down approximately \$45,000.00 from May 2016.

He confirmed that the increase in the MUA's debt service from capital improvement projects will have little impact on the 2018 Budget.

The next phase of projects will probably have budgetary impacts in 1-2 years so the budgets can be adjusted accordingly. The Engineer will provide him and the Board with a list of projects that can be considered in the next phase.

LICENSED OPERATOR

Robert De Block submitted report, which is on file.

The Lead and Copper Plan has been submitted, revised and is now on hold pending NJDEP review.

The WQP Sampling Plan was discussed at length. Sampling is required every 14 days. The MUA is doing weekly samples starting July 1.

The Lead Sampling testing calls have stopped. The Operator is requesting permission to contact property owners to schedule appointments. The MUA discussed the issued and gave the Operator the authority to contact owners.

The Operator will assist in initial training meeting and management of the summer intern.
