CHAIRMAN

Victor D'Ambrosio spoke on the following:

He regretfully accepted Commissioner Malgosh's resignation from the Authority board. Commissioner Malgosh was an original Commissioner from when the Authority was created in 2004. He worked very hard in his position and will be missed. He gave his best wishes to Commissioner Malgosh.

All schools have taken responsibility to perform their own lead testing. The Authority is continuing to receive more information regarding lead testing procedures.

The Heights Tank issues will be discussed in the Licensed Operator or Engineer reports.

The financing for the 2014 Improvements Project is closing this week.

Discussion was held concerning the Licensed Operator transition.

Discussion was held concerning the 960 Belmont easement. The issue is still under Engineer and Attorney review.

He received the Draft Financial Statement and is reviewing same.

ENGINEER

Justin Mahon submitted report, which is on file and addressed any questions.

On June 7, the cleaning and disinfecting of the Heights Tank occurred. The project was completed. Higher pressures were experienced by some customers around the time of the project; however, the pressures were due to a valve malfunction and not the cleaning and disinfection project.

He had a discussion with the Developer's Engineer concerning the 960 Belmont easement and is waiting for revised documents.

He provided an update on the 2014 Improvements Project – the Pre-Construction Meeting will be scheduled before July 7; Notice to Proceed will be issued approximately a week after the meeting; and the Engineer will prepare a letter to users that they may experience an increase in pressure along with other possible consequences that will be hand delivered to customers.
