• REPORTS AND DISCUSSION

CHAIRMAN

Victor D'Ambrosio spoke on the following:

Discussion was held concerning the water main breaks at Harring Court. Generally, there are 1 to 2 breaks per year. In the past, the MUA tried to perform a project in the area but the MUA could not get the cooperation of the residents in order to obtain the easements required to do the work. The Licensed Operator and Engineer are now recommending a different approach with a new line in the general right-of-way and in the area of one user, who may be cooperative. The MUA needs to examine the budget before undertaking the project further.

The review of the sampling stations is pending.

The Developers Agreements are in progress for the 960 and 920 Belmont projects.

Under the 2014 Water System Improvements Project, the Contractor is present and discussion will be held concerning certain issues.

The Licensed Operator wants to retire effective September 1; however, he is agreeing to continue to work with the MUA as a consultant on various projects. The Chairman thanks him for his many years of invaluable service.

The MUA received correspondence from the attorney for the North Haledon Board of Education. The matter will be discussed in Executive Session.

The Interlocal Service Agreement with Haledon has been finalized and is being considered for approval tonight.

The MUA received the tank report, which will be discussed in the Engineer's report.

The Morrissee Avenue account is under review by Joanne Van Hook and the Chairman.

The High Mountain Presbyterian Church matter will be discussed in the Engineer's report.

The North Haledon Bond has been secured and provided.

Letters have been sent to customers concerning the 2014 Water System Improvements Project.

ENGINEER

Justin Mahon submitted report, which is on file and highlighted the following:

The Harring Court project cost is approximately \$17,000.00-29,000.00; however, it will avoid the cost of the annual repairs if the new pipe is installed.

The High Mountain Presbyterian Church requested that the MUA extend the existing service to 198 Squaw Brook to its buildings at 200, 202 and 204 Squaw Brook. The North Haledon Plumbing Official will have to review and approve the connection. Also, connection fees must be considered if the line is to be tapped before the meter. He believes it will be two meters for the three properties.

The 960 Belmont project was discussed.

Discussion was held concerning the 2014 Water System Improvements Project. The first approved Payment Request is for \$156,740.23. The original bid price will be increased because the Contractor has experienced more rock and more costs for traffic control.

The Heights Tank Report was discussed. The recommended work should be done over the next 3-5 years.
