#### **CHAIRMAN**

Victor D'Ambrosio spoke on the following:

# **ENGINEER**

He reviewed the 2014 Capital Improvements Project, which has been delayed to the NJDEP review of the project. The new anticipated bid advertisement is likely the Fall of 2015 and therefore work will likely not start until the Spring of 2016.

He is working with the Licensed Operator to identify water leaks in the system.

The Kemp valve installation has been completed; therefore, that project can be closed out.

She confirmed that the Kemp work had been completed to the property owner's satisfaction according to his attorney.

North Haledon has forwarded the signed Interlocal Services Agreement for the use of the Borough's tax collector for the 2015 MUA water utility lien sale.

# **AUDITOR**

Chuck Ferraioli spoke on the following:

He reported that the billings are approximately \$127,104.00 less than this time last year. The major monthly billing difference was in January when in 2015, \$14,076 was billed versus \$130,980 in 2014. If this holds out until the end of this year, the MUA may have a deficit. He is unconcerned about this year; however, if this trend continues next year, there will be financial concerns. He has discussed the matter with the Chairman and both agree that obtaining a Note to cover the shortfall does not make fiscal sense due to the high costs involved in such a venture. The Chairman is going to research the matter with Joanne in order to determine whether or not there may have been a computer problem with the billing system was upgraded.

The type of water change that was experienced in the four month period is generally due to a change in chemistry; however, there has been no change in the property owner's service area. There may be a difference in chlorine residual. There is no service loop in that area so the fact

that it is a dead end may also have something to do with the issue. The Licensed Operator will follow-up with the property owner and check the hydrant in the area.
