REPORTS AND DISCUSSION

CHAIRMAN

Victor D'Ambrosio spoke on the following:

There was a significant water main break and there was significant difficulty and delay in finding it because it was located near a storm drain. Boil Water Notices were issued.

He thanked the MUA staff along with the Offices of Emergency Management of Haledon and North Haledon for their assistance during the main break.

He also thanked the residents who were affected for their patience during this emergency.

He will be meeting with representatives of the Borough of Haledon to discuss Standard Operating Procedures and to improve future emergency communication with residents.

Maps of the system's hydrants is complete; however, still under review. It is a good start but not complete. It is hoped that the final list will be don in the next flushing cycle and will list correct way to operate the hydrant.

The MUA is looking to purchase at least one vehicle; however, this purchase is on holding pending the new state contracts.

The purchase of the valve turner is on hold and it was suggested that this money be used in another area.

The requested insurance quote from the JIF is in process.

The Emergency and Repair Service Agreement has been finalized with J. Fletcher Creamer.

The LFB has approved the temporary funding for the upcoming project at its August 8th meeting. Commissioner Bernard Jones had contacted MUA verbally in reference to resigning from Board; however, he has still not submitted his written resignation. The Chairman thanks him for his service; however, due to the length of his many absences, he will send a letter to Mayor and Council to make a request that they appoint a new Commissioner for a full board.

North Haledon's OEM notified the MUA of a service named NIXLE- a free mass communication notification of any emergency.

The NJEIT issued a letter concerning funding that will be addressed by counsel since it involves pending litigation.
