• REPORTS AND DISCUSSION

CHAIRMAN

Victor D'Ambrosio spoke on the following:

He advised that the first capital improvement project, which consists mostly of water main work is almost complete. A punch-list has been sent to the Contractor so hopefully all issues will be addresses and completed by the next meeting.

The second project involving the Central Avenue Standpipe is proceeding. The standpipe is currently out of service so that the work could begin. The professionals have advised that there will be no interruption of service during the completion of this work.

The third project involving the Former Filtration Plant and High Service Reservoir should begin soon. The interim financing closing will be taking place in the upcoming weeks for the funds necessary for projects 2 & 3.

He confirmed that the new MUA 450 Truck has not been delivered. Commissioner Van Sickle advised that the delay is due to the State ordering so many trucks and the State's order takes precedence over the MUA's order. Commissioner Van Sickle is keeping an eye on the situation since pursuant to the bid, the truck must be delivered in 120 days.
