• REPORTS AND DISCUSSION

CHAIRMAN

Victor D'Ambrosio spoke on the following:

The Chairman asked for a moment of silence to commemorate the 9/11 and hurricane victims. He advised that the hydrant flushing began today. The flushing is an important part of the Authority's maintenance program. Some customers may experience brown water but the water is within acceptable drinking standards.

The Authority's website update is in progress.

Discussion was held concerning the water application filed by the Haledon Board of Education.

ENGINEER

Justin Mahon submitted report, which is on file and addressed any questions.

Discussion was held on the site inspection at 220 Pompton Road. The source of the low pressure has not been found; however, he is awaiting the results of the hydrant testing for potential answers.

The Water Quality Accountability Act passed in July. The Act places additional requirements upon utilities, specifically on valve maintenance.

He is updating the Water Meter Replacement Pilot Program to include the inspection of all schools serviced by the Authority.

The Meter Pit Inspections are in progress.

A site visit was conducted at the Gatherings Development; however, additional testing is needed and advanced notice will be required for the testing to take place.

The 960 Belmont project received its water main extension permit from the NJ DEP. Construction is moving forward at the project.

He is working on the updates for the Capital Improvement Plan that were discussed at last month's meeting.

Several estimates were received regarding the Authority's sale of its scrap meters. The United Scrap Iron estimate will yield the most money for the Authority so that is the one recommended for acceptance.

AUDITOR

Chuck Ferraioli spoke on the following:

There is currently a revenue shortfall of \$200,000.00 which will likely mean that there will be a budgetary shortfall at the end of the year of \$100,000.00. He is not concerned about the 2018 Budget; however, there may be an impact on the 2019 Budget.

Discussion was held concerning how to generate less fluctuating revenues (for examples, a fixed capital service fee or a fixed/variable fee). This was an initial discussion; however, the issue should be considered well in advance of introducing a fee like this into the rate schedule.

Discussion was held on various maintenance items.

Discussion was held concerning the new cellular based alarm systems at the pumps, including but not limited to call and email contact lists.

The NJ DEP approved the Authority's Water Quality Sampling Plan and the Lead and Copper Plan.
