• REPORTS AND DISCUSSION

CHAIRMAN

Victor D'Ambrosio spoke on the following.

He explained that hydrant flushing and flow rate analysis are being done along with documenting what way each hydrant opens for firefighting purposes. Upon conclusion, a map will be created 10/15/12

to document all of the results. He apologized to the users for any inconvenience during this process.

The work is done on Central Avenue in North Haledon and a hydrant was repaired on Belmont Avenue.

He thanked the Licensed Operator for preparing for the MUA's approval Standard Operating Procedures for Emergency Situations, which have been forwarded to all OEMs and Borough Officials.

The MUA would like to purchase two (2) vehicles, which are needed to conduct the MUA's work. Commissioner Van Sickle will research and monitor the state contracts for this potential purchase.

The Engineer is recommending a switch from chloramines to chlorine. Both are antiseptics; however, the use of chlorine will reduce problems with the MUA pumps. The MUA will notify residents by letter and web-site. PVWC will notify DEP of this change.

The Engineer is requesting an increase in the budget for survey work necessary for the upcoming NJEIT project.

He advised that Mitch Hanenian has passed away. He expressed his condolences to Mitch's family and friends. Mitch will be missed.

He stated that the Leak detection project has been completed. Although there is approximately thirty five percent (35%) loss of water, the contractor did not find significant leaks within the MUA's system. Leaks were detected on customer's side of pipes. Letters will be sent to affected users.

He discussed the NIXEL communication system. This is a free system offered by the federal government. It is posted on Borough of Haledon system and is offered to OEM. People must register with the system and then they will be contacted by text and/or e-mail in the event of emergent situation. The MUA shall research this service further before implementing it. This service would not replace the MUA's reverse 911 system, website postings and letters to the Borough Clerks.

He advised of a change to the night's Bill's List Debt Service payment to Borough of Haledon. Auditor suggests that the payment be amended to \$80,000.00.
