Galbraith, is being consideration for a maximum of 120 days at \$300 a month. He welcomes George to the MUA.

2011 Water Main Improvement Project- the MUA has submitted a letter of intent to the NJEIT. Senior Discount- He spoke with Auditor to look into for implementation into the 2012 Budget.
