Victor D'Ambrosio spoke on the following:

He advised that he received an e-mail from the DEP stating that there is a drought watch in Passaic County; therefore, customers should use care with outdoor water facilities.

He met with Borough representatives to discuss contract related concerns, which will be discussed in Executive Session.

The work has been completed on 59 Post Street. A bill has been received and is under review.

The Authority received a positive chloraphorm result in violation of DEP standards; however, the Engineer will update on this issue further.

The next meeting date may be changed to November 16, 2015; however, this will be confirmed and advertised.

He explained that the positive chloraphorm sample results were from Manchester High School and the North Haledon elementary school. Discussion was held concerning revising the sampling sites because there is a history of problematic results due to the use patterns in the schools. He stated that notices must be sent setting forth the factual circumstances and explaining the violations. The language of the notice is being worked on by the Engineer and Licensed Operator. In addition, a report must be filed with the DEP stating what corrective actions will be taken.

He submitted a proposal for services for the upcoming capital improvements projects in the amount of \$209,000.00. The proposal is under review.

He discussed the letter for the 920 Belmont Avenue project that was prepared and sent to the developer for additional information.

He advised that the 960 Belmont Avenue project is still under review.

The Commissioners authorized the Licensed Operator to purchase a new sampling station in the amount of \$1,683.00 for future use.
