He met with PVWC representatives on October 16, 2013 to discuss alternatives to resolve the potential disinfection byproduct violations caused by using chlorination instead of chloramination in the system. They agree to perform a short term sampling program before the November regulatory sampling and to evaluate incorporating aeration into the improvements at the Central Avenue Standpipe and High Service Reservoir.

He advises that Reivax Contracting Corp. is seeking additional monies for paving. His office is attempting the mediate this issue. Reivax is addressing the final punch list items for the project. JNP has demolished the piping in the valve vault and started making modifications to the Central Avenue Standpipe. He seeks a Change Order incorporating the alternately bid Tasks 4 through 8 into the pending contract.
