Water Clerk is in need of two computers. The staff will obtain cost estimates for this equipment. Implementation of on line credit card payments would could approximately \$1,200 a year. The \$10 charge would be absorbed by the ratepayer, who chooses to utilize the system. This capability would be for the ratepayers' convenience.

Based upon the amount of delinquent accounts that the MUA currently has, it is in the best interest of the MUA to have a Water Lien Sale to collect past due amounts.

Two easements have been obtained for the 2011 WSI Project.

Two quotes have been provided for a hand operated valve turner for approximately \$3,000 versus the larger item costing approximately \$60,000.

The Insurance Company responded in reference to damages done to the fire hydrant on West Broadway and requested that the MUA waive the administrative fee on invoice.
