• REPORTS AND DISCUSSION

CHAIRMAN

Victor D'Ambrosio spoke on the following:

November 2013 Minutes are being finalized so they will be held over to next meeting.

Lien sale to be held for delinquent accounts, which total approximately \$90,000.00. Haledon's tax sale is on December 19th. The MUA will not be joining in that sale; however, it will be utilizing the services of Haledon's tax collector to perform its sale sometime in February. The MUA will contact North Haledon to inquire into using the services of their collector to perform a sale in that Borough.

A Close Out Change Order is presented and recommended for NJEIT Project 2011, which will decrease the total project cost by \$96,000.00.

Borough of Haledon has contacted MUA requesting that "Welcome to Haledon" be added on the Central Avenue Water Tank. The Contractor has advised that the additional cost is \$1,500.00. The Borough has not approved this cost as of the date of the meeting. Discussion was held on this request.

The disposal of items anticipated in the Former Filter Plant/High Service Reservoir project is still under review as to responsibility for the costs.

Malcolm Pirnie will be attending a meeting with the North Haledon Planning Board to discuss the plans for the Former Filter Plant/High Service Reservoir project.

The capability for ratepayers to make on-line payments is in process.

Quotes have been received for the purchase of two computers that are needed by the MUA staff.

Motion made by Van Sickle seconded by Zofrea to remove the "Manchester Utilities Authority" lettering from the Central Avenue tank and add "Manchester Utilities Authority" in small lettering on the door to the tank.

The MUA may need to execute a Change Order for the Central Avenue Tank project to extend the contract deadline.

He will be attending the meeting with the North Haledon Planning Board to discuss the plans for the Former Filter Plant/High Service Reservoir project. He is awaiting cost estimates for additional work.

There are 300 old meters at the property. The MUA needs to determine if it wants to sell them for scrap at approximately \$2-3 per meter or potentially auction them. Unfortunately, the auction places are not calling Angelo Passafaro back.
