He provided an update on the 2014 Water Improvement Project – all mains are completed; however, paving cannot occur until Spring of 2017. PSE&G will also be completing its project and paving, which will be coordinated with the MUA. A Change Order will be needed to extend the Contract term. The amount of additional costs cannot be determined at this time.

He advised that Arcadis is preparing a conservation of water response to the NJDEP, which is due by the end of the year.

She discussed the need to publish the Request for Qualification for Professional Positions for the upcoming year.

AUDITOR

Chuck Ferraioli spoke on the following:

He introduced and discussion was held concerning: (1) the 2017 Connection Fee increase in the amount of \$213 from last year for a total of \$3,257, which is still below the state average; (2) the 2017 Budget of \$3,038,656.05; and (3) the 2017 Rate Increase of Two Percent (2%). The MUA has spent approximately \$12 million dollars on projects over the past few years and those projects have to be paid for. The MUA has consistently approved smaller increases each year to make it easier on customer. The 2% increase is a bare minimum increase and every effort is made to control costs.

LICENSED OPERATOR

Robert De Block submitted report, which is on file.

Discussion was held concerning a leak at the intersection of Belmont and Squaw Brook roads.

He recommended stocking items to address leaks that way the MUA will save on emergency contract time for the contractor to obtain the materials.
