• REPORTS AND DISCUSSION CHAIRMAN

Victor D'Ambrosio discussed the following items:

A teleconference was held with the operators in order to discuss the stand by time issues. Further discussion will be held in Executive Session since it involves contract concerns.

The main focus remains the nonrevenue water numbers and actions to address them.

Information concerning relief for customers facing financial burdens due to the COVID-19 pandemic is scarce; however, the Authority will continue to look for ways to help customers. Moratorium on collection efforts for residential accounts continues to be in effect until January. Acoustical Grant is moving forward – the Purchase Order was placed on hold pending formal action at this meeting.

He is reviewing a Draft Letter to North Haledon residents regarding the well contamination issues some residents are facing.

The Authority passed its laboratory testing.

555 Preakness will be discussed under Engineering Report.

ENGINEER

Jerry Mitchell submitted report, which is on file and discussed the following items:

Grant application for Acoustical Testing Pilot Program was approved and the Grant Agreement has been received and reviewed by the Professionals. Funding should soon be transferred to the Authority. Northeast Water Technology has requested the issuance of a Purchase Order to order the acoustic meters. Arcadis will be providing the Authority with a schedule for billing meter data collection which will need to be followed to allow data analysis and proper reporting to the BPU. Arcadis is working with the Licensed Operator to evaluate and address THMM levels.

Hurricane Ida has exposed a 6-inch water main crossing a stream at the Circle Avenue Bridge. Valves on either side of the bridge have been identified for shut down should this line fail. Arcadis has evaluated an appropriate method of repair and is currently in communications with the County on overall restoration of the stream channel.

Based on a priority list most of the fire hydrant repairs/replacements have been completed and this list is being compared to the fire hydrants on the Phase 2 leak repair list.

Review of estimated accounts continues.

920 Belmont – connection to club house was completed with the initial water main looper but not put into service. A temporary meter has been used for irrigation. Owner has received approval of a new connection for irrigation and should be installing the meter soon.

555 Preakness – Contractor didn't contact Engineer regarding main installation. Contractor didn't follow drawings and the tap was put in the wrong spot. The tap connection is being removed and the situation is being monitored by the Engineer.

ATTORNEY

Casey Cordes submitted report, which is on file and discussed the following items:

Acoustical Testing Pilot Program – the Grant Agreement was reviewed and comments were provided. Resolution was prepared for consideration.

Work is continuing to prioritize and address the delinquent accounts in the most efficient way possible. The second round of letters offering deferred payment plans have been sent to delinquent accounts with balances exceeding \$1,000.00 (21 accounts).

Policy regarding estimates was discussed – new policy would be to discontinue service if customer receives 2 estimated bills in a row and does not contact the Authority so it can be investigated. This policy would address the ongoing problem with accounts that have several quarters with estimated bills.

AUDITOR

Robert McNinch discussed the following:

Discussion held on 2022 Budget. The Budget will be introduced in December.

Rate considerations will be presented at the next meeting.

Cash flows are tight and are continuing to be monitored. Account receivables were approximately \$600,000 in September and were reduced to \$500,000 in October; however, the average around this time is usually \$300,000.

LICENSED OPERATOR

Robert De Block submitted report, which is on file and discussed the following items:

The Authority needs to complete an Operational Evaluation regarding TTHMs by December 22, 2021.

Additional flushing has been discussed with the operational staff for James Court and they have doubled the manual flushing at that location. Staff has collected an additional sample for TTHM at the hydrant closest to 555 Preakness to determine if the high TTHMs are a result of the low usage in the building or the main that services the building.

Lead and copper sampling for the compliance period of 1/1/2019 - 12/31/2021 was completed. A copy of an example consumer sample tap letter is attached for your review. The 90% for lead was 1.65 ug/L (the Action Level is 15 ug/L). The 90% for copper was 0.07 mg/L (the Action Level for copper is 1.3 mg/L). The staff will continue to obtain ongoing materials evaluations for specific locations each time the Authority staff access a meter. The Chairman thanked all of the Lead and Copper sampling participants for their involvement, which is essential to this process.
