• REPORTS AND DISCUSSION

CHAIRMAN

Victor D'Ambrosio spoke on the following:

The MUA has struggled for two years to locate the source of the non-revenue water increases. All resources are being limited and focused on solving this problem; however, the 10% rate increase is necessary to meet 2021 Budget needs. Over the years the MUA has limited rate increase to 2% even when direct costs were exceeding that percentage. For example, PVWC annual rate increases were generally 5%. It was a difficult decision; however, the MUA must be fiscally responsible and the increase was the only way to meet the Budget costs. The rates are still more affordable than private companies and discounts are still available for qualifying senior citizens.

The deadline for Professional Requests for Qualifications is January 21, 2021.

The Interlocal Service Agreement was approved by the Borough of Haledon and is on the Agenda for approval by the MUA tonight.

Based upon the telemetry upgrades, the Verizon lease lines can be disconnected which will be a cost savings to the MUA.

ENGINEER

Justin Mahon submitted report, which is on file and discussed the following items: Focus has been on non-revenue water actions.

Recommendation to approve the Northeast Water Technologies proposal for \$7,750.00 to complete Phase 2 of leak detection work for he 383 pressure gradient.

Received the report from Northeast Water Technologies for Phase 1 of the leak detection work. Small leaks were identified and will be repaired by Garcia Construction.

Investigation is ongoing as to whether open valves have been allowing water flow back to the PVWC system.

DPW and Licensed Operator have confirmed that there are no leaking tanks or tank overflows.

Updated monthly summary of water usage and daily pumping station flows as tools to quantify and locate non-revenue water issues.

Weekly progress reports have been submitted to the Chairman.

ATTORNEY

Casey Cordes submitted report, which is on file and discussed the following items:

The Interlocal Service Agreement status was reported on by the Chairman.

The Public Notice for Requests for Qualifications has been prepared and is on the Agenda for approval by the MUA tonight.

AUDITOR

Robert McNinch discussed the following:

The rate increase was reported on by the Chairman.

The 2021 Connection Fee increase of \$4,004.00 is calculated by statute. The amount is still lower than the majority of water authorities.

The 2021 Budget is \$3,258,000.00. He recommends introducing the Budget tonight. Then it will be submitted for Local Finance Board approval. Once it is approved, it can thereafter be adopted by the MUA.

The Debt Service payment is being monitored. He will follow up with Denise as the due date approaches.

LICENSED OPERATOR

Robert De Block discussed the following items:

On December 5 there was a water main break on Willie Street. Garcia Construction was mobilized by the DPW. A controlled shut down was necessary to complete the repairs.

They are continuing to work with PVWC on valve closures and meter readings irregularities.

Recommendation was made to purchase the vacuum since it is needed for the Phase 2 leak detection work.
