Checks for Bidding Documents shall be payable to the Manchester Utilities Authority.

Bid security shall be furnished in accordance with Article 8 of the Instructions to Bidders. Any applicable surety bond shall be written by a surety company listed on the Federal Treasury List (Department Circular 570-Surety companies Acceptable on Federal Bonds). Bidders shall furnish proof of qualifications to perform the Work as described in Article 3 of the Instructions to Bidders.

Bidders may choose to attend a pre-bid meeting as described in Article 6 of the Instructions to Bidders. Attendance is not required. The pre-bid meeting is to be held on April 9, 2025 at 10:00 a.m. at the Heights Tank location.

Bidders shall comply with all statutory requirements in accordance with Article 24 of the Instructions to Bidders.
