### **CHAIRMAN**

This notice announces an outline of the relief measures for residential ratepayers experiencing economic hardship during the COVID-19 pandemic.

### INSTALLMENT PLAN AVAILABILITY

BE ADVISED that State law requires residential customers to be offered an installment plan for any water arrearages accruing between March 9, 2020 and March 15, 2022.

### LATE FEES, CHARGES AND PENALTIES

BE ADVISED that state law prohibits local governments from charging residential customers interest, fees, or charges for late payment of water charges accruing between March 9, 2020 and March 15, 2022 until after March 15, 2022 at which time interest and penalties may begin to accrue.

### BILL ASSISTANCE AND ARREARAGE FORGIVENESS PROGRAMS

The application period for the New Jersey Department of Community Affairs' Low Income Water Assistance Program (LIHWAP) is now open. This federally funded program will provide financial assistance to low-income households to reduce the balances on their residential water and sewer bills.

The Borough of North Haledon Police Department's request concerning a communication tower at the filter plant property is progressing.

The issue of non-revenue water continues to the be focus of the MUA.

The State funding forms have been completed and sent to the State to be finalized. Awaiting information from the State on the next steps.

A request was made to the Borough of Haledon Mayor Stampone to appoint an alternate Commissioner in order to avoid future meeting cancellations.

The position of Treasurer needs to be addressed since Commissioner Flach cannot service in the position due to her employment conflict.

Action Items for consideration are the Badger Meter Invoice and Website Training Invoice.

### **ENGINEER**

Jerry Mitchell submitted report, which is on file and discussed the following items:

<u>27 Church Street</u> – the flow meter is now fully operational. A memo has been prepared and circulated concerning the lost revenue from January 2018 to the end of December 2021 at this location.

<u>PFAs Contamination Issue</u> – Arcadis seeks approval to pursue further discussions with property owners and NJDEP in order to potentially expand its distribution system to service outside properties who currently have well systems contaminated by PFAs. Arcadis prepared a PFAs Area Map and PFAs contamination Summary.

Acoustical Testing Pilot Program – The first leak detection monitoring Summary Report has been received for the period 4/13/22-4/26/22. A total of nine (9) leaks were reported and have been prioritized for repair by the MUA.

### **ATTORNEY**

Casey Cordes submitted report, which is on file and discussed the following items:

<u>Contracts</u>- Reviewed the proposed Data Sharing Agreement and Vendor Agreement that will allow the Low Income Household Water Assistance Program (LIHWAP) to pay arrears for qualifying customers. The Agreements were revised, executed by the Chairman and sent to the State for processing.

<u>Delinquent Accounts</u>- Work is continuing with the Billing Clerk to prioritize and address the delinquent accounts in the most efficient way possible.

2021 Audit was discussed. There were no corrective comments, so it was a clean report.

Chairman thanked Denise Wahad and the staff for their efforts.

### LICENSED OPERATOR

NJDEP is requiring submittal of a Capital Improvement Report, which must be submitted by June 3, 2022. The professionals are working on developing the information in the format requested. This will be an annual submittal requirement.

Quotes are being obtained for the compressor requirements for Reservoir Road.

<u>TTHM</u>- The Public Notification for the First Quarter TTHM exceedances was mailed on April 1, 2022. The Certification was completed on April 4, 2022. Staff is continuing to daily flush James Court in an effort to reduce water age and control TTHMs. Due to the rolling average, the Second Quarter will likely require another notification.

<u>Non-Revenue Water</u>- The meters for Camp Varitans and Stone Industries were installed. Communications are ongoing with PVWC regarding potential unmetered interconnections and purchased water history.
