All Qualifications should include, at a minimum; the name, address and all contact information of the person or firm making the proposal; a statement of qualifications, including all applicable professional Licenses held; a statement of experience in rendering such professional services to public entities; references; and a proposal for compensation or a schedule of fees to be charged for such professional services.

All Qualifications will be evaluated by the Commissioners of the MUA on the basis of the Qualifications deemed to be most advantageous, price and other factors considered. The evaluation will consider:

- (1) Experience and reputation in the field;
- (2) Knowledge of the Manchester Utilities Authority and the subject matter to be addressed under the contract;
- (3) Availability to accommodate any required meetings of the Manchester Utilities Authority;
- (4) Compensation proposal;
- (5) Other factors if determined to be in the best interest of the Manchester Utilities Authority and its agencies.
