• REPORTS AND DISCUSSION

CHAIRMAN

Victor D'Ambrosio spoke on the following items:

He explained that all rate increases are taken very seriously by the Board. The Board tries to keep any and all rate increases as low as possible to really just meet budgeted operating expenses. This is not easy considering needed infrastructure improvements and the annual rate increase issued by PVWC, which was 6% this year. The Connection Fee is still much lower that the state average of \$10,000.00.

The letter was sent to PVWC outlining the billing adjustments owed to the MUA. There is a Resolution for consideration tonight to void past payment checks and to make adjustment for the estimated credits. The Resolution is recommended for approval by the Auditor.

The Notice received from the State regarding TTHMs will be explained by the professionals.

He expressed his thanks to Denise Wahad and the website consultant for addressing the MUA's recent website issues.

ENGINEER

Jerry Mitchell submitted report, which is on file and discussed the following items:

<u>Action Item</u>: Recommend approval of a six (6) month extension to the Construction Valve Exercising Contract with John Garcia Construction due to delays that were beyond the contractor's control.

<u>Operations</u>: Additional energy data was requested from PVWC that the BPU requires be included in the final report for the Acoustical Testing Pilot Program. Once received, the final report will be completed and sent to the BPU and the grant will be completed. The MUA now owns the acoustical loggers which still have 2 to 3 years of battery useful life remaining. Implementing a scaled back

leak monitoring plan should be considered. This issue will be addressed by the Operations Committee.

<u>Water Quality</u>: Coordinating with the Licensed Operator to identify lead service connections. Work Orders are being issued for inspections. Over 150 responses have been received from the lead service survey.

<u>Facilities</u>: Holland Chrisitan Home Water Main Extension Project: The design work has begun. Long term funding will be sought for the project once it is designed and publicly bid.

920 Belmont Project- Letter must be sent concerning non-payment of additional service connection fee for the irrigation system. The total owed is \$82,082.00.

1278 Belmont Avenue – Garage construction which is very close to the MUA's water main.

978 Belmont Avenue – Planning Board Notice received.

269 Pompton Road – Connection request was received; however, a response has not been sent because replacement plans for galvanized water mains are not complete.

<u>Management</u>: The status of the North Haledon PFAS contamination of water supply wells will be discussed at next month's meeting.

Annual rolling average for NRW has decreased slightly to 33% in December of 2023.

Capital Improvements: The 2019 Draft Asset Management Plan is being updated.

ATTORNEY

Casey Cordes submitted report, which is on file and discussed the following items: Policy: 2024 Rate Schedule changes were discussed.

Delinquent Accounts: Heights at Haledon Condo Association made payment.

920 Belmont was sent a letter concerning the amount owed. Denise Wahad has followed up with them on two occasions and no response has been received nor has payment be made. Recommend counsel following up at this point.

Robert McNinch discussed the following items:

2024 Items: Connection Fee, Budget, and Rate Increase discussed.

Resolutions: The November and December PVWC bills on the Bills List Resolution have not been adjusted; therefore, the Board must address those bills.

LICENSED OPERATOR

Robert De Block discussed the following items:

Operations: The Annual WQAA Certification was submitted on December 27, 2023.

Options for laboratory analysis are being evaluated since PVWC advised that they will no longer process.

The Wheeling Charge needs to be implemented effective January 1.

<u>TTHM</u>: The Updated Remedial Measures Report and Corrective Actions Completion Certification have been submitted to the NJDEP. An Operational Evaluation Level Exceedance Notice was received from the NJDEP and was discussed.

<u>Lead & Copper</u>: There are 21 services that need to be inspected. Once completed, the sampling list will be finalized, and communication can begin with targeted properties to confirm their willingness to participate. Sampling is scheduled for June through September of 2024. Responses from the survey are now at over 200.
