2018 Water Improvement Project application is proceeding.

NJDEP input has been received on the Lead and Copper Plan. The Licensed Operator is addressing the comments.

Badger Meter has provided an invoice in the amount of \$4,800.00 for an annual maintenance contract. This contract has not been renewed. Discussion was held on the issue.

Welcomed the DPW staff members who operate the Authority's system: Dave Quaglietta and Gerard Denny to the meeting.

ENGINEER

Justin Mahon submitted report, which is on file and discussed the following items:

Extensive discussion held regarding preliminary SCADA communication update options. Further investigation items on: "All Site" proposal versus "Remote Login" proposal; additional municipal references; and financing options.

Prepared Water Quality Assurance Act (WQAA) certification form with assistance of Licensed Operator for action. The Certification is due on October 19 and will coordinate with authorized representatives the online submittal.

88% of the hydrants were tested in the Fall flushing program. Provided updated hydrant list that was used for Fall flushing and will complement the Spring flushing program for purposes of the WOAA.

2018 Water Improvements Project – two bid packages have been prepared: one for replacing the High Service Pump Station and the other for rehabilitating the Heights Tank; application is in process; interim financing may not be available until December 2018.

Association for Environmental Authorities is providing comments period suggestions on state financing changes – this may be something the MUA wants to pursue – discussion held.

"Flint" staffing information reviewed as benchmark information.

LICENSED OPERATOR

Robert De Block submitted report, which is on file and discussed the following items: September Disinfectant Residuals Report was submitted to NJDEP on October 9, 2018.

Trienniel Lead and Copper sample collection has been completed. We have received all of the 30 samples required. All samples were within acceptable levels. Result reports will be prepared and sent to each participant once official laboratory reports are received from PVWC.

Staff is responding to the NJDEP comments to the updated Lead & Copper and WQP Sampling Plans. Revised documents will be submitted within the next two weeks to the NJDEP.

On September 18 the operating staff identified an issue with the telemetry at the High Service Tank that resulted in a low or no water pressure in some of the service areas. All reports were followed up on to confirm the area impacted. A Boil Water Advisory was issued to the required areas and posted on the website. Following restoration of pressure, staff flushed hydrants on areas that experienced discolored water due to the low pressure. Follow up sampling was completed and the Boil Water Lift notice was issued on September 20 following the receipt of the laboratory results and in consultation with the NJDEP.
